We would like to **formally clarify** that **JPEX Asia** (accessible via https://jpexasia.com) is **not in any way associated, affiliated, or connected** with **JPEX Hong Kong** or any of its related entities.

A recent article published by *The Standard* — "JPEX crypto fraud casts shadow over Hong Kong nascent policy" — has caused confusion among members of the public due to the similarity in naming. We wish to make it unequivocally clear that **JPEX Asia operates as an independent organization** with a completely distinct management team, business direction, and operational framework.

### No Connection or Business Relationship

JPEX Asia operates as an independent company with its own management, business model, and operational structure.

We have **no ownership ties**, **shared personnel**, **shared systems**, **or collaborative ventures** with the organization mentioned in the above article (JPEX Hong Kong or its affiliates). Any assumptions or associations between the two entities are **incorrect and misleading**.
